Subject: Re: RCRA

Misao Shiba-San,

I am sending this to both your Lotus Notes and Profs addresses. Sorry that it has taken me so long to get back to you.

I am not aware of any 3M fluorinated compounds that are specifically listed as hazardous in RCRA. Daryl Huggett, our ET&SS (Environmental Technology and Safety Services) resident expert on RCRA or Tim Koenig, a representative from SCD on the copy list, can correct me if they happen to know that I am wrong.

Some 3M fluorochemicals, however, would be included in certain RCRA hazardous waste categories because of their characteristics or usage.

We have the Title 40 of the U.S. Code of Federal Regulations (40 CFR) on our computer system. Using Lotus Notes, I will forward (separately from this memo) those lists and those hazardous waste descriptions from 40 CFR that I think could be useful to you. Let me know if the lists I forward do not meet your needs.
