Saxeexista hoosta, waxaan oggolahay oo oggolaanayaa in macluumaadka aan bixiyo ay u isticmaali karaan ama ku faafi karaan Xafiiska Xeer Ilaaliyaha Guud ee Minnesota: (a) si loo xalliyo arrinta aan la xiriiray Xafiiska, oo ay kujirto la xiriirida qofkasta ama cidda ka cawday; (b) inay ila xiriiraan; (c) wakaaladaha kale ee xoojinta sharciga iyo / ama wakaaladaha ka caawiya macaamiisha; iyo(d) haddii kale gacan ka gaysato dhaqan-gelinta sharciga. Marka laga reebo sida kale ee oggolaanshahaan oggolaaday, waxaan fahamsanahay in macluumaadka aan bixinayo loola dhaqmi doono sidii "xog gaar ah oo shaqsiyadeed" sida ku xusan Sharciga Dhaqanka ee Xogta Dowladda ee Minn. Stat. ch. 13, loomana isticmaali doono mana faafin doono marka laga reebo sida uu fasaxay sharciga ama qaanuunka kale ee gobolka ama federaalka.
