The thrust of their claims, that opioid manufacturers and distributors could be held responsible for the opioid epidemic, were entirely novel and untested in courts. Keller Postman and its cocounsel not only investigated these claims and reported their findings to their Minnesota clients in order to guide them through the MDL process, but it also took on substantial risk by bringing untested claims on behalf of their clients. During the course of the MDL, Keller Postman and cocounsel regularly kept their clients informed about developments in the MDL and since the announcement of the settlements between litigating government entities in the MDL and the Second Wave Defendants, Keller Postman has liaised between its clients, local counsel, and its clients' the attorney general's office to ensure participation in the settlements.

Keller Postman immediately began working with its clients in order to ensure participation in the settlement agreements by speaking to its clients' city attorneys, mayors, city councils, and county boards. It attended meetings with the Minnesota attorney general's office to advocate for increased allocations to its clients in order to secure their participation in the settlement agreements and recommended the settlements over the course of several months, which successfully led to a 100% participation rate in the settlements from its clients.
